PURPOSE AND OUTCOME

Course Overview: This course will cover the analysis and interpretation of data collected from longitudinal studies, that is, studies where measurements on subjects are repeated through time. The course will explore the development and implementation of relevant statistical models using R (the statistical computing software). The course will emphasize interpretation and implementation of these models, theoretical results will be mentioned but are not the focus of the class.

Relation to Program Outcomes: This course serves the knowledge and skills student learning objectives by preparing students to communicate the underpinning of biostatistics concepts and methods and to apply biostatistical concepts and methods on one's own, including interpretation and communication of results.

Course Objectives and/or Goals:

Upon successful completion of the course, students will be able to:

- Explore and summarize correlation structure in longitudinal data
- Apply, evaluate, and interpret the output of linear, generalized linear, marginal, and random effects models as well as generalized estimating equations using statistical software (R).
- Report the results of a longitudinal analysis to peers

Instructional Methods: Lectures

Description of course content, topical outline, and course schedule

The following is a general outline of the main topics covered in the course (order subject to change depending on class progress and schedule):

1. Review of linear regression

2. Introduction to basic programming in R
3. Introduction to vector and matrix notation and multivariate normal distribution
4. Exploratory data analysis for longitudinal data
5. General and generalized linear models for longitudinal data
6. Marginal models
7. Random effects models
8. Generalized estimating equations

Assignments

Students will complete three graded exams (two midterms and one final exam). Each exam will involve working with a real-world data set to implement the concepts learned in class. Students will be expected to use R to produce relevant plots, fit appropriate statistical models, and write up a formal report on their analysis. This course focuses on progress and improvement in data analysis, therefore exams will count for an increasing proportion of the student's grade as the course progresses.

Recording Within the Course:

Students are allowed to record video or audio of class lectures. However, the purposes for which these recordings may be used are strictly controlled.
